Brief Description of Proposed Action (include purpose or need): Adoption of a Local Law amending portions of the Zoning Code of the Town of Copake governing requirements for solar energy facilities within the Town of Copake. The Town of Copake recognizes that solar energy is a clean, readily available, and renewable energy source and that energy generated from solar energy systems can be used to offset energy demand on the grid where excess solar power is generated. At the same time, potential benefits of solar energy must be reconciled and balanced with other important interests of the Town of Copake and its citizens, its farmland, and its businesses. Given recent changes in state energy policy, the creation of the Office of Renewable Energy Siting, and aggressive state targets for new solar power generation and battery energy storage system capacity, the Town of Copake expects to see an increase in proposals for solar energy and battery energy storage facilities of all sizes in the Town. The Town of Copake desires to amend its zoning code to further align solar energy zoning provisions with the goals and objectives set forth in the 2011 Town of Copake Comprehensive Plan and 2014 Town of Copake Farmland Protection Plan. The proposed modifications to the law support state energy policy by promoting appropriate solar development while further protecting existing community character, valuable farmland, and other exceptional local resources. The law also evinces the Town's intent for state siting bodies to strictly apply all substantive provisions in the Town Code.
